

## Privacy policy of MedicaExpert.pl

For the sake of medicaexpert.pl users, we have prepared a document describing what data concerning the website users we collect and how we process them. Please read the following provisions.

The administrator of the collected data is MedicaExpert Conference Mateusz Lubarski with the registered office in Miechów Wesoła 9, 32-200 Miechów, mailing address: Bociana 4c/33, 31-231 Kraków, NIP: 6591496495, REGON:120464850 called as Data Administrator.

The Privacy Policy has been adopted by the Data Administrator out of concern for the safety of personal data of medicaexpert.pl website users, in particular to prevent access by unauthorised persons.

The Data Controller shall ensure that the principles adopted in this privacy policy shall ensure that all users of the medicaexpert.pl website shall exercise their rights under Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC. in particular the right to inspect their own data, the right to request updates and deletion of data and the right to object in the cases specified in that Act. The above rights are exercised by sending an email to the Data Controller with the relevant request to the email address: [biuro@medicaexpert.pl](mailto:biuro@medicaexpert.pl).

In relation to the use of medicaexpert.pl website, the Data Administrator may collect the following data on users: e-mail address, login, password - to be provided by the user voluntarily during site registration, first name, surname, professional licence number, profession, medical specialisation, address of residence, correspondence address, voivodship and country of residence, place of work, telephone or fax number and date of birth. The scope of data on specific users depends on the category of the user, and providing personal data is necessary for proper provision of services within the medicaexpert.pl website.

All data processed by the Data Administrator shall be protected pursuant to the provisions of the law on personal data protection. User data shall not be used by the Data Administrator for any purpose other than to enable the user a proper access to the services offered at medicaexpert.pl.

In addition, we also collect information about the IP numbers of devices that connect to the website located at <http://www.medicaexpert.pl>. The data collected in this way are used to analyse and verify the operation of our website. Thanks to this data, e.g. visit statistics are built, which allow for a reliable estimation of the level of interest in the service. We also use the information about IP numbers for technical purposes - all in order to provide users with high quality services.

In any case, personal data of users are not merged with IP numbers of devices connecting to the website. Some areas of the website may use cookies, i.e. text files saved on the user's device, identifying him/her in a manner necessary to enable certain functions of the website. The above also applies to users who are not registered on the website.

Users' personal data is not disclosed to third parties, except in cases strictly specified by law. Personal data of the user will also not be visible to other users of the service, except for the data which the user has voluntarily placed in the service.

The Data Controller shall ensure that every effort is made to process personal data with the greatest respect for the privacy of data subjects and

with the utmost care for the security of the personal data processed, and in particular shall ensure that it has taken all measures prescribed by law for the protection of the data filing systems, including in particular

1. shall apply technical and organisational measures to ensure the protection of the processed personal data, appropriate to the risks and category of data protected, and in particular shall protect the data against their disclosure to unauthorised persons, against their appropriation by an unauthorised person, against their processing in violation of the Act, and against their alteration, loss, damage or destruction;
2. maintain documentation describing the way in which the data are processed and the measures referred to above;
3. Only persons authorised by the Data Controller shall be permitted to process the data;
4. ensure control over what, when and by whom personal data is entered in the file and to whom it is transmitted;
5. keeps a register of persons authorised to process personal data.

The Data Controller reserves the right to update and change this privacy policy by publishing a new version on this page. We hope that our policies will always allow you to enjoy a comfortable use of our website. #### Rights of the data subject

The data subject shall have the right, according to the nature of the personal data, to request access to his or her data, to rectify, erase or restrict the processing thereof, and to object to the processing of personal data.

#### Automated decision-making, including profiling

Personal data is not subject to automated decision-making, including profiling.

#### Right of action

The data subject shall have the right to lodge a complaint with the President of the Office for Personal Data Protection in Warsaw in the event that the data is processed contrary to the applicable legal provisions.
